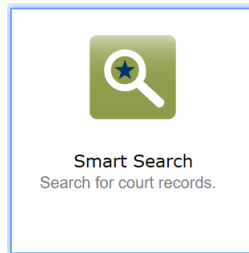


Public Portal and Courthouse Terminal Smart Search

Smart Search *Required

Search Criteria

Type the record number in the search criteria field. To perform a wildcard search, type a minimum of four characters followed by an asterisk.

You can also type a name in Last, First Middle Suffix format. To perform a wildcard search, type a minimum of three characters followed by an asterisk for the last name, and a minimum of one character followed by an asterisk for the first name.

For a precision search, click Advanced Search Options to expand additional search fields.
